FILL, SCRATCH & WIN!

TERMS AND CONDITIONS OF PROMOTION

- 1. The promotion "FILL, SCRATCH & WIN!" (hereinafter "the Promotion") begins on April 25, 2025, at 10:00 am and ends on June 30, 2025, at 10:00 pm.
- 2. The rules of this Promotion will be available, as of the commencement of the Promotion, in the Puma Energy Puerto Rico website, at https://pumaenergypr.com/stt
- 3. Those eligible to participate are the legal residents of St. Thomas that are 18 years or older at the time in which they participate, and who have a valid driver's license. This Promotion is limited to the geographical area of St. Thomas and is subject to the applicable statutes and regulations. Neither employees, immediate family members (spouse, parents, siblings, children and the spouses the latter) nor persons that reside with employees of PC Puerto Rico, LLC or of its subsidiaries, owners, administrators or employees of the Puma Energy service stations, its attorneys or any other entity that helped in the development, production or implementation of this Promotion, including DDB Latina, can participate in the Promotion.
- 4. Any client who purchases Puma Energy brand fuel at any of the participating Puma Energy service stations in St. Thomas, and follows the instructions indicated herein, can participate for the prizes described in the section "PRIZES".
- 5. Every participant recognizes having read, understood and accepted these terms and conditions, and agree with them. Any intent to break the rules of this Promotion, or to give false information with the intent to defraud, will be processed as per the applicable laws. Participations that are false, fraudulent or deceitful will make them become ineligible to participate in the Promotion. Participations that are illegible, incomplete, or that are not duly filled out will be disqualified.
 - The participating Puma Energy service stations are those located in St. Thomas, that appear in the listing at the end of these rules.
- 6. The term fuel refers solely and exclusively to Puma Energy brand 87 octane gasoline, 93 octane gasoline or diesel that is sold in the participating Puma Energy service stations in St. Thomas.
- 7. PRIZES: During the duration of the Promotion, 15,000 prizes will be given, which are broken down as follows:
 - I. Scratch and Win Instant Prizes:
 - a. Six thousand (6,000) prizes of a \$1.00 discount applicable to purchases of Puma Energy brand fuel through Puma Fast Pay.
 - b. Two thousand (3,000) prizes of a \$3.00 discount applicable to purchases of Puma Energy brand fuel through Puma Fast Pay.
 - c. One thousand (1,000) prizes of a \$5.00 discount applicable to purchases of Puma Energy brand fuel through Puma Fast Pay.

To redeem the \$1, \$3 or \$5 fuel discount prices listed above, the winner must have the Puma Fast Pay application registered, which can be done for free. In the Puma Fast Pay application, the winner must go to the "settings" and look for the section of promo code and enter the code that appears in the coupon.

These \$1, \$3 or \$5 discounts will only be applied if the winner uses Puma Fast Pay to pay for the Puma Energy fuel brand. The prize will be redeemed at the end of the next fuel purchase made through Puma Fast Pay after winning the prize. These prizes must be utilized on or before June 30, 2025. Otherwise, they expire.

d. Nine hundred five (905) prizes classified as "Green Label", which can include any of the following: foldable red Puma chairs (36 prizes), a 30" x 60" white beach towel (368 prizes), Super 7 plastic cups in multiple colors (130 prizes), a stainless bottle (108 prizes), white & black cooler bags (63 prizes), and hand fans (200 prizes). The personnel at the Puma Energy service station, and not the participant, chooses the prize, which will depend upon availability.

The prize must be claimed with the scratched coupon, and proof of purchase, within a period of seven (7) days counted from the day after the purchase date. Otherwise, they expire. The prize must be claimed at the service station in which the purchase was made.

II. Prizes through Drawings:

The client must deposit the participation coupon in the urn that has been duly identified for said purpose in any of the participating Puma Energy service stations.
